OF DONORS, BUT NO DECISION WAS MADE.

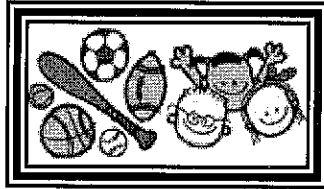
2011 Park Budget & Projects:
